Discussion and thoughts on PreK program:

PreK is currently at 10 students. Over 10 we would need an additional aide. The program has struggled since the start, not a financially viable program. Reasons to discontinue the Pre-K program:

- Most important would be the space constraints at the school.
- Program is break even at best, not financially beneficial.
- Not feeding the kindergarten as we hoped.
- Filling the PreK teacher position has been continually problematic.
- Current PreK teacher has no intention to return.

We could change course in the future, depending on demand.

Strawberry Communications.

Tony Hull- Strawberry Communications proposed an agreement of \$200/mo, free monthly phone service as well as 100MB of backup internet bandwidth for UEN failures. In exchange SHCS would provide 2 points on the backside of the school for 3-4 small tower pieces (4-5' tall, not exceeding 6' per tower). Towers are to provide internet service, not cellular service.

Jon Hagen- Not comfortable with the cancellation provision included in the contract as proposed. Investment is too great for Strawberry Communications to participate in a contract with a cancellation clause. If we are requiring a cancellation clause Jon would like to return to the drawing board on the agreement.

Tony Hull- We need the ability to cancel the contract (with valid reason) as the board is always changing year to year.

Jon Hagen- Not interested in the agreement if that means that we could have the rug pulled out from under us at any time.

Discussion on pros/cons of the agreement, modifications that could be made to the contract to appease all parties involved. Jon Hagen and Tony Hull will continue to work through this and try to come to an agreement on a contract with a mutually beneficial and fair cancellation clause. Interested in moving this forward if we can come to an agreement on cancellation clause. Revisit in 2 weeks at the next board meeting.
